WHEREAS, the contract is being awarded pursuant to a "fair and open" process in accordance with N.J.S.A. 19:44A-20.5; and

WHEREAS, the bid submitted by Binsky & Snyder Service, LLC has been reviewed and deemed by the Housing Authority's architectural and engineering firm, qualified purchasing agent and legal counsel to be responsive and conforming with all requirements as set forth by federal procurement law, New Jersey Local Public Contracts Law, the public advertisement for bids, and the bid package; and

\$147,500.00

2. Binsky & Snyder Services LLC

\$198,675.00

The bid from the apparent lowest bidder GBS is missing required critical legal forms and is deemed unresponsive by the Authority's legal counsel. The second lowest bidder is Binsky & Snyder Services LLC from Piscataway, NJ with a total bid price of \$198,675. In accordance with Alternate #1, if the Authority elects to acquire only one Rooftop Air Handling Unit, the Binsky & Snyder Services LLC bid includes a deduct of price \$103,338.

Netta Architects has reviewed this Bid Submittal and found Binsky & Snyder Services LLC to be the most responsible low bidder, and therefore recommend that the Housing Authority award the contract to Binsky & Snyder Services LLC. We also recommend that the Housing Authority's legal counsel verify all submitted documents before award.
