#### **PUBLIC COMMENT:**

James, the Authority's IT contractor speaks and thanks the Board for its time. He indicates that he has been the Authority's contractor for a year and a half and that he wanted to come in and introduce himself to everyone in person as he likes to have a hands-on relationship with his clients. In his time here, the GHA's vulnerabilities have been patched and the IT data and buildings are now all safe.

He indicates that Ruddys touched upon a few things going over to the cloud – this will allow the Authority to do things in real time. Some of the changes this will allow will be to remove antiquated ways of communication with those on the outside (faxes to maintenance staff for instance).

He is asked whether new servers need to be purchased – he says no – all emails have already been moved from the exchange server to the cloud. This was done as the servers were almost 10 years old and Windows is phasing out the operating systems. The servers are still running to control the network but not for using the emails. The data will be recovered and backed up automatically on the cloud. The cloud vendor is government and HIPPA compliant.

Executive Director Andrade indicates that he is looking forward to working with Jim on this.

#### Resolution No. 2019-31

RESOLUTION APPROVING AND AUTHORIZING THE HOUSING AUTHORITY TO ENTER INTO A COLLECTIVE BARGAINING AGREEMENT WITH LIUNA RESIDENTIAL CONSTRUCTION AND GENERAL SERVICE WORKERS LOCAL UNION NO. 55

Date Introduced: September 3, 2019 Date Adopted: September 3, 2019

WHEREAS, the Housing Authority of the Town of Guttenberg ("Housing Authority"), a public entity organized and existing pursuant to the Code of Federal Regulations, the Department of Housing and Urban Development ("HUD"), and the laws of the State of New Jersey, has determined that it is in need of temporary per diem laborers to supplement its existing regularly employed maintenance department for in housing residential unit reconditioning; and

WHEREAS, it is the desire of the Housing Authority to utilize minority and low-income residents for this per diem workforce; and

WHEREAS, LIUNA Residential Construction and General Service Workers Local Union No. 55 ("Local No. 55"), which is affiliated with the Laborers' International Union of North America, has a historical presence in the Town of Guttenberg for recruiting and training minority and low-income residents for employment; and

WHEREAS, Local No. 55 has agreed to actively recruit residents of the Housing Authority amongst its minority and low-income residents for said training and employment; and

WHEREAS, the Board of Commissioners and the Executive Director of the Housing

Authority wish to encourage the training and employment of its residents; and

WHEREAS, the Executive Director has negotiated a collective bargaining agreement with Local No. 55 in which said Agreement would allow the Housing Authority, when it needs per diem temporary laborers to supplement its existing maintenance department for in house residential unit reconditioning, to hire those workers presented to the Housing Authority by Local No. 55 but absolutely retains the right to hire only those workers that the Housing Authority feels is qualified for said employment; and

WHEREAS, the Board of Commissioners has found that it is in the best interest of the Housing Authority and its overall goal of providing quality affordable housing to its residents to approve and authorize the Housing Authority to enter into a collective bargaining agreement with Local No. 55, subject to General Counsel's review and approval;

#### NOW THEREFORE,

BE IT RESOLVED that the Board of Commissioners of the Housing Authority of the Town of Guttenberg hereby approves and authorizes the Housing Authority to enter into a collective bargaining agreement with LIUNA Residential Construction and General Service Workers Local Union No. 55, subject to General Counsel's review and approval; and

BE IT FURTHER RESOLVED that the Board hereby authorizes and directs the Executive Director of the Housing Authority of the Town of Guttenberg to take any and all necessary administrative actions to implement this resolution, including the execution of the final agreement.
