MEETING MINUTES

This regular meeting of the Board of Commissioners was held on April 5, 2021 as a virtual meeting as a result of the COVID-19 pandemic. The meeting was opened at 6:33 p.m. and the Open Public Meeting Act Notice was recited.

Adequate notice of this Meeting of the Board of Commissioners of the Housing Authority of the Town of Guttenberg was given in accordance with Chapter 231 of the Laws of New Jersey by publishing the meeting date in the El Especialito and the Bergen Record on May 16, 2019 and May 17, 2019, by posting the meeting date at the Guttenberg Town Hall on October 4, 2019, and by posting the meeting date on the Bulletin Board at the main office of the Housing Authority at 6900 Broadway, Guttenberg, New Jersey 07093 on May 13, 2019 and by posting the meeting date on the official website of the Housing Authority of the Town of Guttenberg on April 1, 2021.

EXECUTIVE DIRECTOR'S REPORT:

The Executive Director updated the Board of Commissioners on COVID issues with all but two employees fully vaccinated. Regular business hours have resumed at the administrative offices. The Executive Director updated the Board on electrical issues at 400 68th Street. Rent drop boxes have been established at 136 and 400 68th Street. This will provide less contact. Laundry room at 7005 is 24 hours a day. The Authority is working on the remaining locations to provide this service through a fob system. The electronic arm at 7005 parking lots will have the parking arms installed soon. The Executive Director is in the process of applying for three grants. The Authority is applying for a \$25,000 grant from the NBC/Telemundo Foundation which will be used to expand our food distribution program. A \$250,000.00 grant is being applied for to modernize the elevators at 136. The cost to maintain the elevators is excessive and 400 68th Street would be the next property to have elevators modernized. The Authority is looking into a partnership with Heart to Heart Foundation. It would be the first in the nation and would establish a Seniors for Seniors program in which free of charge any senior resident may take classes which will provide them with a home aide certification. Upon receipt of this certification, the senior will be promised employment and will be paid \$16 per hour for their services and will provide additional income to our residents and assist those who are most in need.
